Public Hearing: Sapphire Renewable Natural Gas

PROPOSED PROJECT

Sapphire Renewable Natural Gas, a subsidiary of GFL Environmental Inc., applied to the N.C. Division of Air Quality (DAQ) for a permit to allow it to accept landfill gas from Sampson County Disposal, LLC and process it into natural gas onsite.

Potential Emissions

Currently, Sampson County Disposal burns off its landfill gas using a flare. Sapphire Renewable Natural Gas proposes to process the landfill gas into natural gas and substantially reduce net emissions across the entire landfill. The facility will be considered a major source and will require a Title V air quality permit.

Air emissions will be controlled by a waste gas thermal oxidizer, a candlestick flare and two hydrogen sulfide removal vessels. Emissions of all modeled toxic air pollutants were less than 1% of their acceptable ambient limit. Due to concerns regarding the presence of per- and polyfluoroalkyl substances (PFAS) at the landfill, the draft air quality permit requires initial testing of the inlet landfill gas for the presence of PFAS and requires the company to disclose information about the emissions of fluorinated chemicals.

Project Location

Sapphire Renewable Natural Gas will be at the Sampson County Disposal landfill at 7424 Roseboro Highway (NC Highway 24) in Roseboro, NC. The address is near Marion-Amos Road, McLemore Road and Mitchell Loop Road.
