• G.S. 150B-19.1(b) directs that

"Each agency subject to this Article shall conduct an annual review of its rules to identify existing rules that are unnecessary, unduly burdensome, or inconsistent with the principles set forth in subsection (a) of this section. The agency shall repeal any rule identified by this review"

Periodic Review was codified in G.S. 150B-21.3A in 2013

Requires agencies to review their existing rules at least once every ten years overseen by the **Rules Review Commission**

Uncertainty if the Periodic Review will satisfy the Annual Review requirements



• G.S. 150B-19.1(b) remains in effect

No statutorily-prescribed format

No reporting requirement

Agency discretion how to conduct

• Developed comprehensive master spreadsheet

- o Compliance with statutory criteria in G.S. 150B-19.1
- Consistency with recently enacted session laws
- Necessary
- o Required by law
- Serve the public interest
- Clearly written
- o Reasonably necessary to interpret federal or state law

Area of Environmental Concern Review

• G.S. 113A-115(c)

The Commission shall review the designated areas of environmental concern at least biennially. New areas may be designated and designated areas may be deleted, in accordance with the same procedures as apply to the original designations of areas under this section. Areas shall not be deleted unless it is found that the conditions upon which the original designation was based shall have been found to be substantially altered.
