City of Wilmington Stormwater Education Program & Tour

The program is new and has limited funding, but uses its single staff member to do outreach and education all over the city. Staff uses a variety of media and giveaways to promote good stormwater management, and reaches audiences from elementary schools to public events. Dave led a tour of three of the city's stormwater facilities, including a bioretention area and two man-made stormwater wetlands.
