Reads conflict of interest statement. Ask if any members would like to recues themselves. None do.

Roll call taken, see above. A quorum was present.

Call to accept minutes. Minutes were accepted.

Item II, A Discuss the by-law package. After discussion, Mr. Bratton and Mr. Taylor motion to table the rules to allow Mr. Reynolds time to make some adjustments.

Item II, B Committee on Rules Readoption Report, Mr. Samuel Bratton, Committee Chair. Mr. Bratton explained the purpose of the committee. The meeting lasted about 15 minutes. Explained that the committee disagreed on one of the staff recommendations:

F .0112, FURTHER REMEDIES, the Committee said it was necessary, the staff needs to come up with better language for this rule, and make sure the Law addresses it use.

Discussion how to proceed with changes with the rule review.

Motion to move forward with Committee recommendation to public comment. Mr. Bratton, second by Mr. Viers. Motion passed.

Item IV. Mining Program Report, Mr. Miller.

- A. Program Staffing Update. Down one engineer.
- B. Program Operations Update:
 - 1. Since August 1, the Program has received 17 applications, and resolved 30 items.
 - 2. Annual fees for 2022/23, about 622 sites out of 737 sites have paid. \sim 84%.
 - a. NOD will go out late October/early November.
 - 3. Annual fees for 2021/22, 34 NOV/start revoking process have been sent the last month.
 - 4. There have been two enforcements with perenties:
 - a. Mining without a mining permit, \$5,000.00.
 - b. Permit violations and mining outside the permit boundaries, \$29,580.00.
 - 5. Denials, 34 permits are going to be added to the database over the next month or so. These are applications that did not complete the permitting process >>>>The database currently does not allow for a reason of denial.

Chairperson Morehead asked for more details. Mr. Milled explained that these were applications that the program acted on, but the applicant did not complete the process.

Mr. North asked had the sites been inspected. Mr. Miller responded that is currently being done at this time.

Mr. North requested that public comments be added to the agenda going forward. The Chairperson agreed.
