I. Facility With Original Emission Reduction Credits (ERCs) Certificate Information

This section provides information to identify the facility that generated the emission reduction. This information can be found on the ERCs Certificate itself. Complete this section for all applications.

A. Owner's Name: The full business name of the facility as registered with the NC Secretary of

State's office and the owner's name that generated the emission reduction.

B. Site Name: The name of the plant or facility that generated the emission reduction. If the

facility operates under a different name than the owner name, enter it in this

space.

C. Site Address: The 911 street address (physical location) of the plant or facility that generated

the emission reduction, not the corporate mailing address. Where the Division

Of Air Quality (DAQ) would go to inspect the facility.

D. City: The city in which the plant or facility that generated the emission reduction is

located.

E. State: North Carolina already entered.

F. Zip Code: The postal zip code for the plant or facility that generated the emission

reduction.

G. County: The county in which the plant or facility that generated the emission reduction

is located.

H. Facility ID No. The unique identification number assigned to the facility by the DAQ. This

number is located on the first page of the air permit. The facility ID No. should

reflect the facility that generated the emission reduction.

I. Original ERC The number of the first, or original, ERC certificate that was issued for the Certification No: emission reduction. This number will be referenced on the current ERCs

was issued, then the original and current certificate numbers should be the same.

J. Date Issued The date on which the original ERCs certificate was issued. This date should be

referenced on the current ERCs certificate.

II. Current Owner of ERCs Certificate Information (if different from generating facility above)

Complete this section if the current owner of the ERCs is other than the facility that generated the emission reduction.

A. Owner's Name: The full business name of the facility as registered with the NC Secretary of

State's office currently holding the ERCs Certificate.

B. Mailing Address: Address where the owner may be contacted by mail.

VI. Emission Reduction Credits to Be Transferred

This section identifies the current ERC certificate number and the amount of emission reduction credits to be transferred in this transaction. Complete this section for all applications.



Column 1: Provide the current ERC certificate number. This number appears on the ERC certificate

itself.

Column 2: Provide the date on which the current ERC certificate was issued.

Column 3: Provide the total amount of emission reduction credits for the current certificate. This value

appears on the ERC certificate.

Column 4: Provide the amount of emission reduction credits to be transferred.

Column 5: Provide the amount of emission reduction credits to be retained by the current holder. The

sum of the values in columns 4 and 5 should equal the value of column 3.

Column 6: Identify the pollutant associated with the emission reduction credits. The pollutant is

identified on the ERC certificate.

VII. Purchase Dates and Prices

This section provides information on the effective date of the transfer of the emission reduction credits.

A. Acquisition Date: Provide the date on which the transfer of the emission reduction credits from the

current holder to the future holder becomes effective.

B. ERC Purchase Provide the negotiated price of the emission reduction credits (in dollars per ton)

Price: that are being transferred (optional).

VIII. Certification by Responsible Official

The application to transfer emission reduction credits must be signed by an authorized representative of the facility that currently holds the ERC certificate. If this facility is a major source subject to the federal Title V operating permit program, then the signatory must meet the regulatory criteria for "Responsible Officials" listed in 40 CFR Part 70.2 (definition of "Responsible Official"). If the facility is a non-Title V facility, then preferably an officer or company official as defined in 15A NCAC 2Q .0304. Please provide the name, title and signature of the facility's authorized representative or Responsible Official and the date on which the application was signed.
