The first meeting of the Oil and Gas Commission (Commission) convened on March 14, 2018, in the Ground Floor Hearing Room of the Archdale Building in Raleigh. Dr. Kenneth Taylor, State Geologist and

OGC Staff Director called the meeting to order at 1:00pm and read the Ethics Statement. Commission members and staff were introduced before Dr. Taylor reviewed administrative issues. Mr. Phillip Reynolds, Commission Counsel, provided training on the North Carolina public records and open meetings laws. Following that, Dr. Taylor presided over the elections of the Commission Chair and Commission Vice-Chair, positions to which James K. Womack, Jr. and Robert C. Reinhardt were elected respectively. Taking the gavel, Chairman Womack asked staff to update the Commission on a number of items on which Dr. Taylor said he would report at the Commission's next meeting. The Chairman adjourned the meeting at 2:12pm.

The second meeting of the Oil and Gas Commission (Commission) was held on May 8, 2018. Commission Chairman Womack gaveled-in the meeting at 1:00pm. Commission Counsel Reynolds led a discussion of the oil and gas petition process and correspondences purportedly seeking the preemption of certain local ordinances. An extended conversation between the Commission Chairman and Commission Counsel regarding the correspondence, as well as the petition process followed. Commission Counsel discussed the Chairman's role in determining the completeness of a petition and the requirements related to a hearing on complete petitions. He also discussed the statutory requirements for scheduling a hearing on petitions that have been deemed complete. Commission Counsel also discussed the Commission's authority related to the preemption of local ordinances and the statutorily required findings that must be made in order for the Commission to preempt a local ordinance. It was noted that the correspondence sent to the Commission prior to its first meeting did not comply with the Commission's rules for submitting a petition and that no applications for drilling units or other drilling permits had been received by the Department.

Regarding Agenda Item 7, the Chairman proposed a briefing schedule for the Commission to address: issues on ethics; oil and gas research results from the N.C. Geological Survey; the current Oil and Gas Statutes; and the current Oil and Gas Rules. Following this discussion, the Chairman requested that potential future meeting dates be identified and prospectively calendared in the event a meeting was needed. The Chairman noted that, should any of the prospectively calendared meetings not be needed, he would cancel the meeting.

Regarding the draft Operating Procedures, the Chairman requested that the members provide input and be ready to vote to approve them after revisions were addressed.

Chairman Womack then shared a presentation about the former Mining and Energy Commission (MEC) during which he discussed the legislative history that created the MEC, and later, the Commission. The presentation outlined MEC accomplishments and how the MEC addressed: (i) pooling, assignment of drilling units, and permitting; (ii) well and drilling site standards; and (iii) water withdrawal, wastewater management, and water supply testing. He also talked briefly about the oil and gas resource and how additional data collection may be needed prior to drilling.

Chairman Womack recognized Dr. Taylor to discuss issues related to per diem, travel, and budget matters. Toby Vinson, Interim Director of the Division of Energy, Minerals, and Land Resources to address the uncertainty the Commission's budget.

Two members of the public addressed the Commission. After Commission discussion, the Chairman adjourned the meeting at 2:42pm.

The third meeting of the Oil and Gas Commission took place on August 7, 2018, in the Department of Natural and Cultural Resources Auditorium at 109 East Jones Street in Raleigh. Commission Chairman James K. Womack, Jr. gaveled-in the meeting at 1:05pm. The Commission voted unanimously to adopt the minutes from the May 8, 2018 meeting.

Chairman Womack led a presentation on the Commission's draft Internal Operating Procedures. The discussion centered on attendance requirements for Governor appointees, telephonic access, restoration of the Commission website, closed sessions, quarterly reports, timeline for meeting notices, and future meetings scheduled for calendar year 2019. The Commission voted to adopt the draft Procedures and Commission Counsel stated that he would review the internal statutory citations and bring any recommendations for revisions back to the Commission for its review and approval at a future meeting.

Regarding Agenda Item 6 on administrative issues, Dr. Taylor briefed the Commission on how to request per diem, research and technical presentations from the Geological Survey, communication processes between individual commissioners and staff, DEQ email accounts for each member, introduced Ryan Channel, Senior Geologist for Oil and Gas Regulation, scheduling quarterly Commission meetings in 2019, and reviewing the schedule of remaining meetings in 2018.

Chairman Womack led the discussion of the document titled, "MEC Unfinished Business for OGC Consideration," which included ten broad topics for the Commission's consideration:

- 4. Internal OGC procedures for managing drilling units.
- 5. Internal OGC procedures for managing pooling orders.
- 6. Forms and submission requirements for drilling units.
- 7. Seismic monitoring during active drilling.

- 9. Air quality monitoring during active drilling.

10. Emergency services requirements for local and state level agencies.

Chairman Womack asked that all MEC information and reports be posted to the Commission's website for review and reference.

Chairman Womack led discussion for Agenda Item 8, regarding a visit to an active drill site in Pennsylvania. Commissioner Stone shared feedback about his trips to Arkansas and Pennsylvania and the opportunity to speak to local government representatives, industry operators, and land owners.

Six members of the public addressed the Commission. Following Commission discussion and comments, the Chairman adjourned the meeting at 3:31pm.

The fourth meeting of the Oil and Gas Commission occurred on October 16, 2018, in the Archdale Building, Ground Floor Hearing Room at 512 N. Salisbury Street in Raleigh. Commission Chairman James K. Womack, Jr. gaveled-in the meeting at 10:10am. The first substantive order of business was the discussion of Committee and Study Group Assignments, led by the Chairman. The Commission unanimously approved the proposed assignments as follows:

The fifth meeting of the Oil and Gas Commission took place on December 4, 2018, in the Archdale Building, Ground Floor Hearing Room at 512 N. Salisbury Street in Raleigh. Commission Chairman James K. Womack, Jr. gaveled-in the meeting at 10:10am. The minutes for the October 16, 2018, Commission meeting were not yet available and it was noted they would be ready for the Commission's approval at the next meeting.

Chairman Womack then discussed the 2019 Meeting Schedule and proposed 11 Commission meetings for the year scheduled in January, March, June, July, September, October, and December, and held in the Lee County Commissioners' Board Room, at 106 Hillcrest Drive in Sanford. The Chairman said that notice would go out to members if meetings are cancelled. Consensus dates for each meeting were discussed and approved by the Commission. The sixth meeting of the Oil and Gas Commission took place on February 12, 2019, in the Archdale Building, Ground Floor Hearing Room at 512 N. Salisbury Street in Raleigh. Commission Chairman James K. Womack, Jr. gaveled-in the meeting at 10:07am. After reading the ethics reminder and calling the roll, the Commission voted to adopt the minutes from the October 16 and December 4, 2018 meetings.

Commission Counsel Phillip Reynolds led the members through a discussion about the election of officers and an explanation as to why an election was necessary at the time. Commissioner Baird nominated Commissioner Womack for Chair, who accepted and was elected unanimously by the members present. Chairman Womack nominated Commissioner Reinhardt to serve as Vice-Chair, who accepted, and was elected unanimously by the members present. The Chairman solicited suggestions on clarifying the statutes pertaining to the election of officers from the members.

Commission Counsel Reynolds then walked the members through the draft Internal Operating Procedures of the Commission, noting that the suggested amendments reflect updates and differentiation between the role and duties of the Commission versus its predecessor, MEC. Members were asked to provide recommendations or revisions and were advised that it was the intention of the Chairman to vote to adopt the amended Procedures at the next meeting.

The Chairman recognized Danny Smith, who introduced himself to the Commission as the Interim Director of the Division of Energy, Minerals, and Land Resources. Dr. Taylor and Jennifer Mundt provided updates to the Commission on Agenda Items 8, 9, and 10. Dr. Taylor then introduced Jim Chapman, Senior Geologist for Oil and Gas Regulation, who was recently hired to staff the Commission. Mr. Chapman led the members through the presentation and dialogue comparing North Carolina and other states' oil and gas

regulations. During the discussion, the Chairman requested that staff provide an update on federal actions related to methane emission regulation and drone-based monitoring.

One member of the public provided comments to the Commission, after which the Commission had opportunity, but declined, to make additional comments. The Chairman adjourned the meeting at 11:52am.
