# 2023 NC E&SC Workshop

Sedimentation Control Workshop was held on December 6, 2023, in Raleigh. This workshop was presented by the NCDEQ - Land Quality Section in partnership with NCSU's Department of Crop & Soil Sciences and the Southeast Chapter of the International Control Association (SE-IECA). This workshop is meant to educate and familiarize design professionals, contractors, inspectors, developers, local governments, and other erosion control professionals with new erosion and sediment control requirements and practices.

# 2023 North Carolina Erosion & Sediment Control Workshop

This year registrants again had two options for how they could participate in the workshop. The first option was to attend the workshop in-person for a combination of morning presentations plus an in-the-field afternoon session. The second option allowed registrants to join the workshop virtually for the morning presentations only. Approximately 114 participants attended the full day in-person workshop and 58 attended the half day virtual workshop.

Morning presenters included representatives from the DEQ Erosion and Sediment Control Program, Stormwater Program, Office of General Counsel, Land Quality Section Regional Offices and NCSU Department of Crop and Soil Sciences. Topics included program updates and overviews, legislative updates, history of erosion and sediment control and research updates. The afternoon field demonstrations/presentations were conducted by NCSU staff and students and workshop vendors. Field topics and demonstrations ranged from the use of flocculants, drones, skimmers, porous baffle functions and different wattles and check dam options to construction entrances and a rainfall simulation.

# **The Erosion and Sediment Control Application is Online!**

Applications for the Erosion and Sediment Control (E&SC) Program are now available online through the Department of Environmental Quality's new <u>AccessDEQ digital hub</u>. Part of DEQ's initiative to modernize and streamline its environmental permitting processes, AccessDEQ is designed to support the regulatory cycle while allowing the public to efficiently conduct business with the department. AccessDEQ provides convenient public access to:

- Permit Applications: Select permit applications are now available online. As AccessDEQ continues to expand, more permits across our regulatory divisions will be available for online applications.
- Online Public Records: AccessDEQ provides instant public access to many DEQ documents and files.
- Maps & Data: Interactive maps and data tools, including environmental sampling data from key divisions are accessible in one place.

The new E&SC online system encompasses all aspects of the permitting process, including submitting and tracking applications, online payment options, plan reviews and compliance actions issued under the Sedimentation Pollution Control Act. Applicants can apply to any regional office\* through the AccessDEQ portal below. The portal may be used to apply for standard reviews or those through the Express Review Program. Once your application/plan has been approved, you can log in to the portal to view the details of your permit, update ownership or contact information, or submit a request for a plan revision.

\*For projects that fall under the jurisdiction of a delegated <u>Local Program</u> contact the appropriate agency for application and fee submission requirements.

### The NC Sedimentation Control Commission

The Sedimentation Control Commission (SCC) was created to administer the Sedimentation Control **Program pursuant to the NC Sedimentation Pollution Control Act** of 1973 (SPCA). It is charged with adopting rules, setting standards, and providing guidance for the implementation of the Act. The composition of the Commission is set by statute to encompass a broad range of perspectives and expertise in areas related to construction. industry, government, and natural resource conservation and quality. All members are appointed by the Governor and serve three-year terms, except for the Director of the Water **Resources Research Institute of the** University of North Carolina, who serves as long as they remain Director. The chairman of the SCC is named by the Governor.
