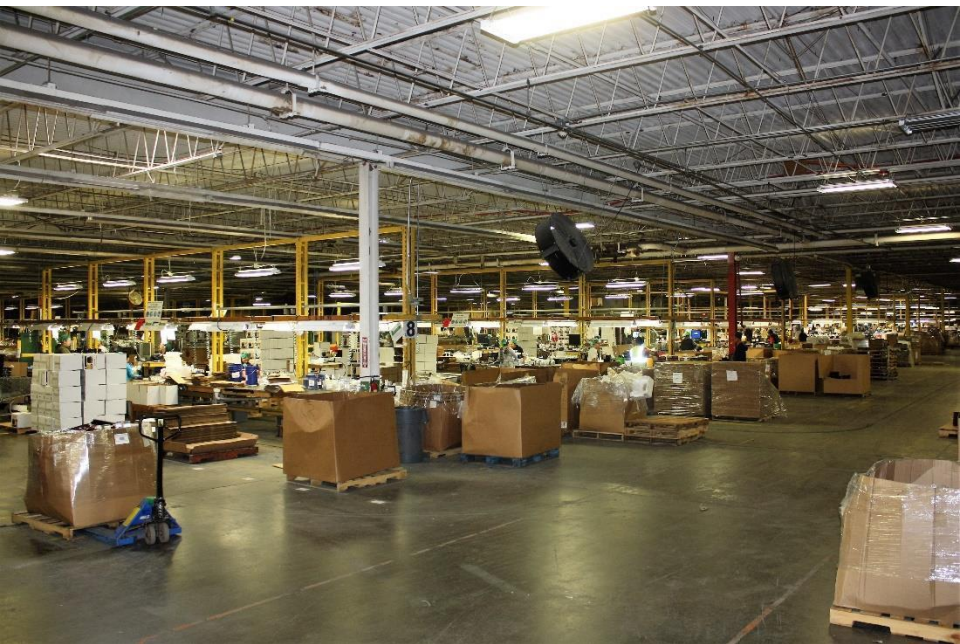

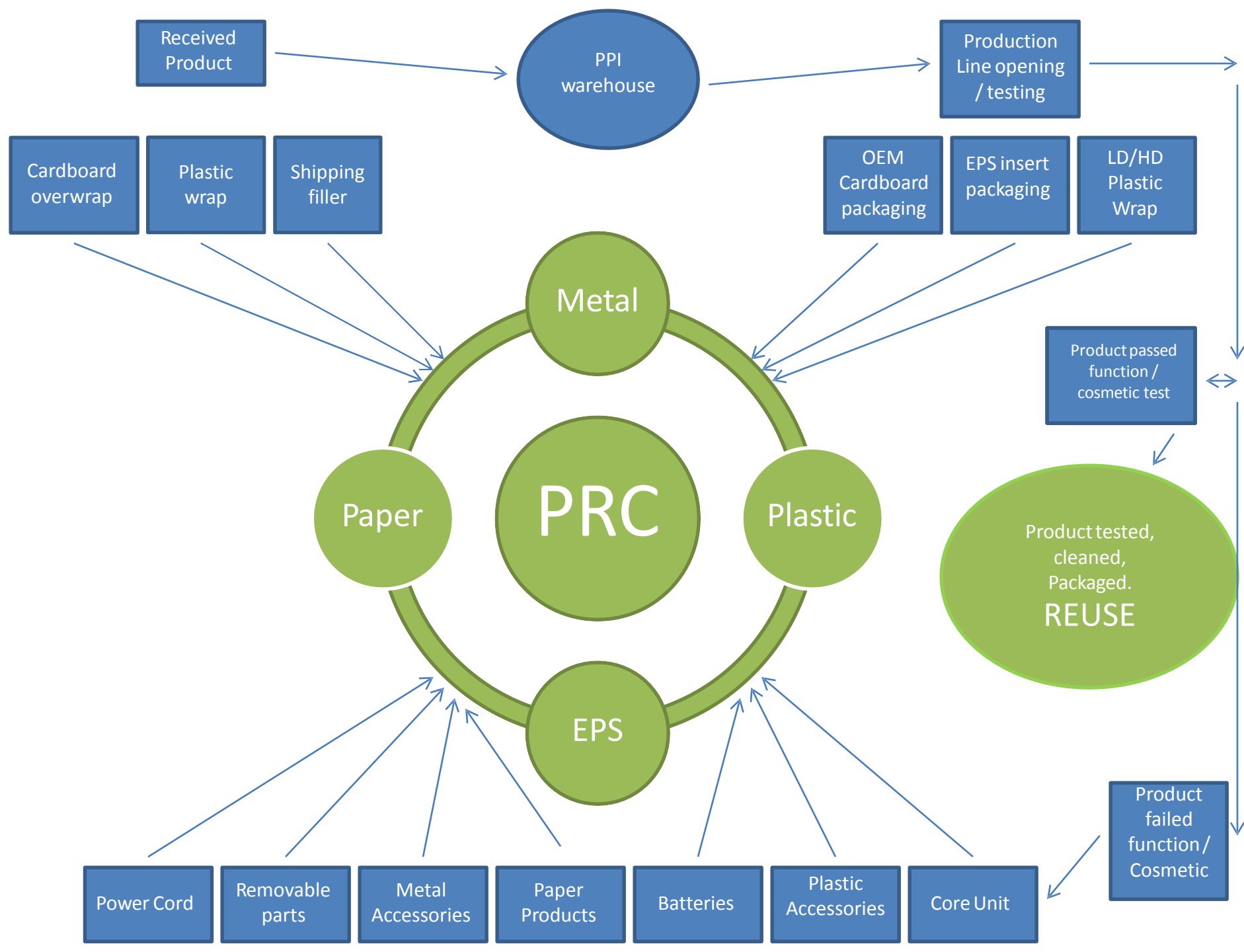

- 2015 Plastic recycling

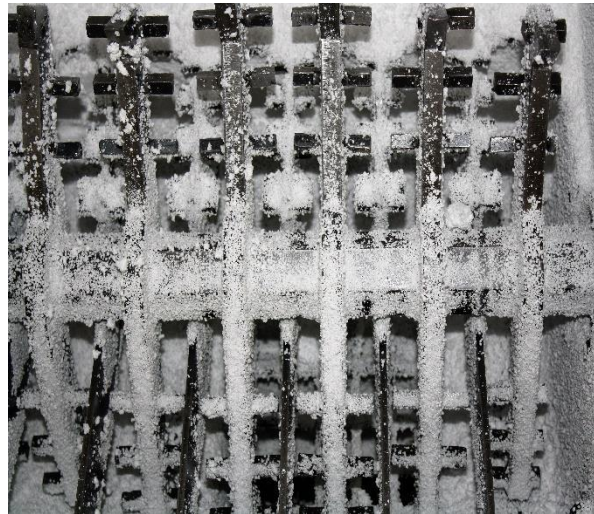


- 128,000 lbs of ABS
 - 68,000 lbs of PP
- 49,000 lbs of Poly C/Poly S

- The reduction of crude oil needed to produce this amount of recycled product is 51,000 gallons or 11 tanker truck loads

PRC NC Recycling Program

- 2015 Expanded polystyrene (EPS)



- In 2014 PRC recycled 152,000 lbs of packaging EPS.
- In unreduced form this amount of EPS will fill a 350,000 sq ft warehouse to the roof
 - This product has a landfill life of 300 + years
