Project Description

The proposed project implements renovations to the existing facilities including upgraded office space, new roofing and roof line, energy efficient windows, façade renovations, screening wall or fencing, exterior painting, HVAC improvements, and a new laboratory will be constructed. Demolition of the North Clearwell and Sedimentation Basins 1 and 2 will occur. Sedimentation Basins 11 through 13 will be constructed in its place and equipped with plate settlers, automated sludge removal systems, and membrane filter systems. A building addition to house the membrane filtration system will be constructed. Improvements proposed for Sedimentation Basins 5 through 10 involve protecting the existing structures from degradation. These improvements include wrapping the existing walkways, wall sections and bottoms within the sedimentation basins. Upon completion of the concrete repair, the entire surface of the sedimentation basins would be coated with an epoxy system.

To satisfy the requirements of the requested Categorical Exclusion, for the subject project, concerning comments from potentially interested agencies, we submit the following:

In regards to the State Historic Preservation Office (SHPO), we state that the components of this project which include the placement of equipment, renovation and upgrades to the existing City of Gastonia's Water Treatment Plant will take place solely within the facilities existing fence line/property line.

In regards to the US Fish and Wildlife Service (USFWS), we state that the components of this project which include the addition of equipment, renovation and upgrades to the existing City of Gastonia's Water Treatment Plant will not change the facility's influent or effluent capacities. In other words, there will be no increase in the Water Treatment Plant's capacity.

In regards to the US Army Corps of Engineers (USACE), we state that construction activities at the existing City of Gastonia's Water Treatment Plant will not occur in a stream, lake, or other body of water or in wetlands. Also, the facility itself is not in a stream, lake, or other body of water or in wetlands. I have determined that no US Army Corps of Engineers Permit is required.
