A Draft Hazardous and Solid Waste Amendments (HWSA) Permit has been prepared for GlaxoSmithKline LLC to continue corrective action activities at the Former GSK-South site under the Federal Resource Conservation and Recovery Act (RCRA). North Carolina has been authorized by the United States Environmental Protection Agency to administer RCRA including the Hazardous and Solid Waste Amendments (HSWA) of 1984. The State has determined that GlaxoSmithKline's proposed activities as identified in the application satisfy the full intent of the North Carolina Hazardous Waste Management Rules and Solid Waste Management Act as amended. When finalized this draft permit issued by the State of North Carolina will constitute a complete permit under the Federal Resource Conservation and Recovery Act.

The Former GSK-South property at 3029 E. Cornwallis Road is owned by the above-listed owners: DRP RTP Genesis, ARE-NC Region No.24, and ARE-NC Region No.25. The owners are redeveloping the site under Brownfields agreement and GlaxoSmithKline continues to conduct RCRA corrective action as the operator as noted above. Proper remediation of hazardous waste contamination found in environmental media associated with solid waste management units and areas of concern is required by the HSWA permit.

The North Carolina Hazardous Waste Management Rules require that the public be given a forty-five (45) day period to comment on the draft permit, which will run from August 2 – September 16, 2023.
