

# North Carolina Department of Environmental Quality Division of Marine Fisheries BLANKET FOR-HIRE VESSEL or NON-BLANKET FOR-HIRE VESSEL COASTAL RECREATIONAL FISHING LICENSE (CRFL) APPLICATION INSTRUCTIONS (REV 2024-12)

Attached is an application for a Blanket For-Hire Vessel Coastal Recreational Fishing License or a Non-Blanket For-Hire Vessel License. Either the operator of the vessel, the owner or a business agent may apply. A United States Coast Guard operator's license is not required for application although all operators of for-hire vessels must be properly licensed by the USCG. The Blanket For-Hire Vessel CRFL covers the recreational fishing license requirements for all anglers aboard the vessel when fishing in coastal waters but not joint or inland waters. The Non-Blanket For-Hire Vessel License does not cover the licensing requirements of passengers so each angler 16 years or older must hold a valid Coastal Recreational Fishing License. Both licenses are available for 6 or fewer passengers or more than 6 passengers. See NC General Statute 113-174.3 for regulations governing for-hire licensing. Individuals applying for a license for another under the authority of Power of Attorney must submit a **PHOTOCOPY** of the Power of Attorney and current picture identification.

Provide a **PHOTOCOPY** of one of the following current picture identifications:

- Driver's License; or
- State Identification (issued by DMV); or
- Military Identification; or

- Passport; or
- Resident Alien Card (green card)

If you are applying as a business, you <u>must</u> provide:

- If incorporated, a **PHOTOCOPY** of Articles of Incorporation and list of current corporate holders.
- If organization, a **PHOTOCOPY** of the Articles of Organization and list of current corporate holders.
- If written agreement partnership, a **PHOTOCOPY** of written partnership agreement.
- If <u>not</u> incorporated, organization, or written partnership, a **PHOTOCOPY** of current Assumed Name Statements, filed with Register of Deeds in the business county, and a **PHOTOCOPY** of business privilege tax certificates, if applicable.
- Current annual reports for LLC or INC.

#### A Blanket For-Hire VESSEL CRFL Application:

- Complete the Vessel Survey (Vessel usage survey definitions)
  - <u>Charter Boat</u> any for-hire vessel typically hired on a <u>per trip</u> basis.
  - o <u>Head Boat</u> any for-hire vessel typically hired on a <u>per person</u> basis.
  - <u>Guide Boat</u> a for-hire vessel typically less than 30' carrying a fishing guide and one or more recreational fishermen.
  - o <u>Dive Boat</u> any vessel engaged in underwater diving that allows persons to take fish for recreational purposes.
- Sign and date the Application.
- Complete the NC DMF License Certification Statement Form. It must be notarized if applying for a new license.
- A PHOTOCOPY of valid vessel state registration or U.S. Coast Guard Vessel documentation.
  - > If applying for a transfer of ownership and the U.S Coast Guard Vessel Documentation is pending, a notarized bill of sale will be accepted.
- A **PHOTOCOPY** of all valid United States Coast Guard Operators certifications (Masters, OUPV, etc.) suitable for the passenger rating you are applying for.

#### Fees:

- See Commercial License and Permit Fee Sheet. If you need assistance, please contact any NC DMF License Office or call (252) 515-5500 or (800) 682-2632. Replacement Fee: There is a \$5.00 fee for replacing current/valid license.
- Method of payment: Personal check, Money Order, Cashier check, Cash (In person only), or Credit Card (In person only). Make payable to *North Carolina Division of Marine Fisheries*. There will be a \$35.00 service charge for returned checks.

You are required to notify the Division of Marine Fisheries of any address or residency changes within 30 days. Incomplete applications submitted without required documentation will be deemed incomplete and returned to you unprocessed.
