Background

This report is submitted to meet the requirements of General Statute 143B-279.20, which requires the Department of Environmental Quality (DEQ) to submit quarterly reporting on applications for permits required for natural gas pipelines and gas-fired electric generation facilities. Specifically, General Statute (G.S.) 143B-279.20, as amended by Session Law 2024-45, states:

§ 143B-279.20. Report on Department activity to process applications for permits required for natural gas pipelines and gas-fired electric generation facilities.

The Department of Environmental Quality shall report on any applications received for permits required for siting or operation of natural gas pipelines and gas-fired electric generation facilities within the State, and activities of the Department to process such applications, including tracking of processing times. The processing time tracked shall include (i) the total processing time from when an initial permit application is received to issuance or denial of the permit and (ii) the processing time from when a complete permit application is received to issuance or denial of the permit. The Department shall report quarterly to the Joint Legislative Commission on Energy Policy pursuant to this section.

At the direction of the Secretary's Office, DEQ has established and maintains an internal review and tracking structure for the permitting of SL 2024-45 related energy projects to facilitate economic development in North Carolina. The tracked information is regularly utilized to create this report for the North Carolina General Assembly and to facilitate communication between DEQ management and other relevant stakeholders to ensure efficiency and responsiveness.

Report Structure

This report is divided alphabetically by project name and includes permitting information from DEQ's Divisions of Water Resources, Air Quality, Waste Management, Coastal Management and Energy, Mineral, and Land Resources. The information provided is up to date as of September 1st, 2025.
