

2025 COMMERCIAL LANDINGS REVIEW

Preliminary data collected by the North Carolina Division of Marine Fisheries reveals that fishermen landed 15.9 million pounds of seafood from January to June 2025. This was a 1.3% increase from the previous five-year average for the same time period as well as a 1.4% increase from 2024 time period.


Pounds of Seafood Landed By Year (January - June)



The top five species landed in North Carolina from January - June in 2025 were hard Blue Crabs (5.5 million pounds), Catfishes (1.3 million pounds), Summer Flounder (1.3 million pounds), Oysters (803,252 pounds), and Bluefish (727,022 pounds).

Since 2020, Hard Blue Crabs have remained the top landed species in the state. Landings in 2025 experienced a 44.0% increase compared to the five year average and a 13.1% increase from 2024. Red Drum landings show a steady increase throughout the time series, 2025 representing the highest landings of the time period, with a 81.6% increase compared to the five year average and a 36.7% increase over 2024.

Shrimp have experienced their lowest year of landings during the five year time series, down 71.4% from the previous January - June 5-year average and 62.1% since 2024.





MANDATORY HARVEST REPORTING

New harvest reporting requirements will impact recreational and commercial fishermen starting December 1, 2025.

In the fall of 2023, the North Carolina General Assembly passed Session Law 2023-137. Section 6 of this legislation requires anyone holding a commercial fishing license who is engaged in a commercial fishing operation to report all fishes harvested to the North Carolina Division of Marine Fisheries (NCDMF), regardless of sale. Additionally, it requires any person who recreationally harvests Red Drum, Flounder, Spotted Seatrout (Speckled Trout), Striped Bass and Weakfish (Gray Trout) to report that harvest to the NCDMF.

This law will have direct impacts to seafood dealers, as commercial fishermen will now be required to unload their harvest, including their personal consumption harvest, at a seafood dealer within 48 hours of landing. Seafood dealers must indicate personal consumption harvest on trip tickets using one of the personal consumption disposition codes: 2 (personal use), 31 (personal use for food), 38 (personal use for bait).

Seafood dealers who do not have the appropriate dealer license category will be allowed to write trip tickets for commercial fishermen who are harvesting catch for personal consumption by using the personal consumption disposition codes for most species. Those species managed under a state quota need to be landed and reported by a dealer possessing the appropriate quota monitoring dealer permit (Estuarine Flounder, Ocean Flounder, Striped Bass, Spiny Dogfish, and Black Sea Bass from North of Cape Hatteras). Mandatory harvest reporting will be enforced by NCDMF's Marine Patrol, and enforcement will be phased in over a period of three years beginning December 1, 2025.

Additionally, any person who recreationally harvests Red Drum, Flounder, Spotted (Speckled) Seatrout, Striped Bass and Weakfish (Gray Trout) must report that harvest to NCDMF using an online reporting form. This applies to Coastal Fishing Waters, Joint Fishing Waters and Inland Fishing Waters adjacent to Coastal and Joint Fishing Waters.

TRIP TICKET REMINDERS

Trip tickets and signed submittals are due by the 10th of the following month. If you know ahead of time that you will not be purchasing seafood during specific months, you may submit a signed submittal (green form) in advance to close out those months, as long as they are within the current license year.

Please note that each license year begins in July, which can only be closed out in advance if the dealer has renewed their license. For the new license year, a signed submittal for July must be submitted by the 10th of August.

Submitting in advance helps keep records accurate and ensures a smooth process for everyone. If you have any questions, contact your port agent for assistance.

TRANSITION FROM PC TRIP TICKET PROGRAM TO VESL

We have been informed by Bluefin Data, LLC that Claude Peterson, PC Trip Ticket's developer and technical support, will be retiring at the end of 2025. As a result, Bluefin Data has announced that all reporting functionality of the PC Trip Ticket Program will be terminated by end of January 2026.

All North Carolina seafood dealers that are required to report electronically and are currently using the PC Trip Ticket Software will need to transition to VESL, a webbased trip ticket reporting platform. It is recommended that dealers consider transitioning to VESL before the end of the year. VESL was recently launched in North Carolina

and is designed to meet both state and federal reporting requirements. We will be sending out additional information regarding this transition, so please be on the lookout for these important updates.

TECH TIP

Welcome to VESL, North Carolina's new electronic reporting option. One great feature of VESL is the ability to lock fields when entering seafood on a ticket. Next to select fields there is a lock icon, which when selected will enlarge and lock your field selection. When used with the ADD & NEW button this feature can greatly speed up your data entry. It is very useful when you're entering multiple species that were landed in the same waterbody with the same gear; or landing different grades of the same species.
