- Standard Commercial Fishing License (SCFL) - \$400.00 or the amount charged to NC residents in the non-resident state whichever is greater. It will never be less than $\$ 400.00$.
- Retired Standard Commercial Fishing License (RSCFL) for age 65 or older - $\$ 260.00$
- Land or Sell License - $\$ 400.00$ or an amount equal to the non-resident fee charged by the non-resident's state, whichever is greater.
- Blocks of 10 Ten Day Coastal Recreational Fishing Licenses (CRFLs) - $\$ 150.00$
