

North Carolina Department of Environmental Quality Division of Marine Fisheries ESTUARINE FLOUNDER DEALER PERMIT APPLICATION INSTRUCTIONS (REV 12-2024)

Attached is an application for the Estuarine Flounder Dealer Permit. It is unlawful for a fish dealer to possess, buy, sell, or offer for sale flounder taken from estuarine waters without first obtaining a Estuarine Flounder Dealer Permit required for specific management purposes for the applicable fisheries and harvest area.

Individuals applying for a permit for another under the authority of Power of Attorney must submit a **PHOTOCOPY** of the Power of Attorney and current picture identification.

Provide a **PHOTOCOPY** of one of the following current picture identifications:

- Driver's License; or
- State Identification (issued by DMV); or
- Military Identification; or

- Passport; or
- Resident Alien Card (green card)

For an Estuarine Flounder Dealer Permit:

- Complete and sign the Application.
- Complete the NCDMF Permit Application Certification & General Permit Conditions Form. It must be notarized if applying for a new permit.
- Complete the ESFLDEAL Estuarine Flounder Permit Specific Conditions Form for Estuarine Flounder.

Fees:

No fee for this permit.

You are required to notify the Division of Marine Fisheries of any address or residency changes within 30 days. Incomplete applications submitted without required documentation will be deemed incomplete and returned to you unprocessed.

It is unlawful for a fish dealer to possess, purchase, sell, or offer for sale flounder taken from estuarine waters without first obtaining an Estuarine Flounder Dealer Permit required for specific management purposes for the applicable fisheries and harvest area.

For violation of specific permit conditions (as specified on this form), permits may be suspended or revoked in accordance with 15A NCAC 03O .0504.

Legal Authority:

Authority for the Estuarine Flounder Dealer Permit is specified in G.S. 113-169.1, 113-221.1, 15A NCAC 03O .0501, 03O .0502, 03O .0503, and 03O .0506.

Specific Permit Conditions:

During the commercial season opened by proclamation or rule for the fishery for which a dealer permit for monitoring fisheries under a quota or allocation shall be issued, it shall be unlawful for a fish dealer issued such permit to fail to:

Fax or send via electronic mail by noon daily, on forms provided by the Division of Marine Fisheries, the previous day's landings for the permitted fishery to the Division. Landings for Fridays or Saturdays shall be submitted on the following Monday. If the dealer is unable to fax or electronically mail the required information, the permittee shall call in the previous day's landings to the Division; **15A NCAC 030 .0503(e)(1)(A)** (15A NCAC 030.0506)

Submit the required form set forth in Part (e)(1)(A) of this Rule to the Division upon request or no later than five days after the close of the season for the fishery permitted; **15A NCAC 030 .0503(e)(1)(B)** (15A NCAC 030.0506)

Maintain faxes and other related documentation in accordance with 15A NCAC 03I .0114; **15A NCAC 03O .0503(e)(1)(C)** (15A NCAC 030.0506)

Contact the Division daily, regardless of whether a transaction for the fishery for which a dealer is permitted occurred; and **15A NCAC 030 .0503(e)(1)(D)** (15A NCAC 030.0506)

Record the permanent dealer identification number on the bill of lading or receipt for each transaction or shipment from the permitted fishery. **15A NCAC 030 .0503(e)(1)(E)** (15A NCAC 030.0506)

It shall be unlawful for a permittee or, anyone engaged in permitted activity, to refuse to allow the Fisheries Director or their agents to obtain biological data, harvest information, statistical data, or harass these agents in any way. Harassment shall be defined consistent with the federal regulations, 50 CFR §600.725(o), (t), and (u), and may be verbal or physical including, but not limited to, sexual connotations, intimidating, resisting, impeding, threatening, bribing, or coercion. **15A NCAC 030 .0502(b)(1)** (15A NCAC 030.0506)

The Quota Monitoring Permits Daily Reporting form does NOT replace trip tickets. All NCDMF Trip Ticket Program reporting requirements must continue to be followed.
