I am writing to strongly oppose the proposed oyster lease on the shoal located near Oregon Inlet. On this same shoal, I maintain a registered duck blind, identified as Blind #50, which My family and I have utilized for waterfowl hunting since the 1950s.

The establishment of an oyster farm in this location would, significantly and negatively impact waterfowl hunting activities in the area. My primary concern lies with the anticipated increase in boat traffic associated with the operation and maintenance of the commercial oyster farm.

This increased vessel presence on and around the shoal would likely disrupt the natural feeding patterns of waterfowl that frequent this area. Waterfowl are sensitive to disturbance, and a consistent increase in boat activity would undoubtedly deter them from utilizing the shoal as a feeding and rest area. The increased boat traffic would negatively alter established waterfowl flight paths during the hunting season and alter recreational fishing and clamming areas during the spring, summer and fall months, that many local fisherman have enjoyed for years.

I respectfully request that decline the the proposed oyster lease due to negative impacts to waterfowl habitats and recreational hunting and fishing around the proposed area that so many local hunters and fisherman have come to enjoy.

I am writing this email to you due to my opposition to a proposed oyster lease coming to my attention in the Oregon Inlet area. The proposed lease referenced above from my research lies North of Blue Pete Island and stretches 3 acres in total area. This puts it's location about 1000 yards South from Dare County duck blind #50, which has been in my family for over 75 years. That shoal already accommodates another Oyster lease about 1000 yards to the West of the blind, which is owned by Savage Inlet LLC. This lease is much closer to the deeper water, which is much better from an ingress and egress standpoint for all concerned. The placement of an additional Oyster lease on the same shoal is not advisable from many aspects, including aesthetically, the sight of hundreds of black drums floating in the shallow water does not add to the natural beauty of the area. That shoal has just started to have aquatic grasses begin to grow on the shoal again after a hurricane covered the grasses completely several years ago. Oyster Farms do not want aquatic grasses in the perimeter of the farms, my understanding is they prefer barren sand. I think your study says the grasses are no longer on this shoal. If there is no grass in this section that makes it ideal natural clam habitat.

That area including the shoal in question is and has been a duck hunting area for 100's of years from October to January each year. The shallows are full of clams and many tourists recreationally clam on that part of the shoal that the proposed lease will be located every day during the summer. The shoal has natural sloughs that run across it for great fishing and during the summer recreational fishing boats are scattered on it as well. With all the shoals in and around the Oregon Inlet area, I can see no reason to have a concentration of oyster processing farms on this one shoal that is currently used recreationally by so many people.

I would strongly urge you to deny this particular lease request for the reasons stated above.

I am currently a board member of a North Carolina Department of Commerce Authority called the NC Marine Industrial Park

As half owner of Herring Shoal Shellfish Co. with Aaron Hopkins, I speak on behalf of Aaron and our company. We are looking to diversify our crop and location with this application. We are looking to diversify for the following reasons. To help bring back a native clam population at the applied location, this location is one of the northern most spots in the state to provide habitat for our native clam that can thrive in the shallow location of the lease. The other reason is to have an opportunity to grow our oyster and clam in a location optimal for growth and flavor, within the rules and boundaries of the state. We aim to respect the local waterman, duck hunters and public.

At our current location, we have had zero problems with duck hunters, waterman, or public patrons using the public waterway. If anything we have heard great reports from the fisherman and the increase in finding Finnish populations more frequently within close proximity our lease. We have also heard of the close duck blinds having a great past couple seasons, no bad effects from our lease have been reported. We also left a 15 ft wide channel through the lease in case people would like to access the middle of the water body if they choose not to use the channels on either side. It's been a great experience.

For the new location there has been concern from the water patrol of a blind 251 feet away and a slough that similarly runs across the shoal at a full tide. There is navigable channels going around all sides of the shoals, and through. If one decides to access the water or a sand island to the west of us, there is a 20-30 feet of a slough that is accessible for the public to navigate if they choose this route. This location will not alter any waterfowl fly ways, by my knowledge. If anything it will help foster and

increase habitat for the species with increased biomass allowing for more food and safe harbor. This is a win for all parties involved.

We are willing to work with everyone to make sure all parties feel respected. We are willing to do what we did with our current lease and provide a channel within the west side of the lease in case one would like to also navigate through our lease with ease. We are looking forward to being great stewards to our waterbody and estuary and provide a local flavor from a sustainable resource that our community can be proud of and stand behind.
