PROCLAMATION

RE: SHELLFISH POLLUTED AREA

Kathy B. Rawls, Director, Division of Marine Fisheries, upon the recommendation of Betsey Tilson, M.D., M.P.H., State Health Director, Department of Health and Human Services, hereby announces that the following changes in shellfish harvesting areas will take effect at sunrise, Saturday, July 16, 2022.

All those waters in Pender, Onslow, and Carteret Counties will return to the status in existence immediately prior to the June 29, July 4, July 7, July 8, and July 10, 2022, temporary closures **except the following which remain closed:**

ONSLOW / CARTERET COUNTIES

<u>All those waters</u> in Stump Sound bordered on the north by the North Topsail High Rise Bridge; and bordered on the south by a line beginning at a point 34° 28.2180' N - 77° 30.5521' W on the mainland near Morris Landing, running southeasterly near Beacon "49" to a point on Topsail Island at 34° 27.273' N -77° 29.937' W.

<u>All those waters from the Intracoastal Waterway to the mainland</u> between IWW Beacon "49" (34° 40.2621'N - 77° 07.9802' W), near Swansboro, and IWW Beacon "55" (34° 38.5749'N - 77° 10.8033' W), to include the Intracoastal Waterway and Queens Creek.

<u>Newport River - All those waters in Newport River</u> upstream of a line beginning at a point 34° 45.6960' N - 76° 43.5180' W on the south shore near Penn Point; running northeasterly to a point 34° 46.5733' N - 76° 42.6350' W on the north shore near the Hardesty Farms subdivision (near the Newport River DMF Shrimp Line).

<u>Core Creek – All those waters in Core Creek</u> upstream of a line beginning at a point 34° 46.3210' N - 76° 41.2515' W on the west shore, running easterly near IWW Marker "25" to a point 34° 46.2251' N - 76° 40.5919' W on the east shore near the mouth of Ware Creek.

North River – All those waters in North River upstream of a line beginning at a point on the west shore at 34° 46.0460' N - 76° 37.0517' W, running easterly to a point on the east shore at 34° 46.2731' N - 76° 35.4724' W (near the DMF Shrimp Line).

<u>Sleepy Creek – All those waters in Sleepy Creek</u> upstream of a straight line across the mouth, beginning at a point 34° 43.2745' N - 76° 31.4600' W on the west shore; running easterly to a point 34° 43.2672' N - 76° 31.2792' W on the east shore.

Jarrett Bay - All those waters in Jarrett Bay upstream of a line beginning at a point 34° 45.9213' N - 76° 29.2047' W on the east shore of Spit Bay; thence in a straight line to a point 34° 45.7944' N - 76° 29.3623' W at the northern tip of Davis Island; thence in a straight line to a point 34° 45.5281' N - 76° 30.1032' W at the "Chimney" near Jump Run Creek.

Oyster Creek - All those waters in Oyster Creek upstream of a straight line across the mouth, beginning at a point 34° 48.8185' N - 76° 26.9761' W on the west shore; running northeasterly to a point 34° 48.9768' N - 76° 26.6340' W on the east shore.

The following also remains closed:

BRUNSWICK / NEW HANOVER COUNTIES

<u>All those waters</u> between the permanent closure line near IWW Marker "89" in Ocean Isle, and the South Carolina State Line, to include the Tubbs Inlet area.

<u>All those waters</u> bordered on the north by a line beginning at a point 34° 04.8476'N - 77° 53.0990' W on the mainland; running easterly near IWW Marker "155" to the southern tip of Masonboro Island at 34° 04.8251'N - 77° 52.9092' W; and bordered on the south by the permanent closure line at Howells Point near IWW Marker "33", to include Bald Head Island, Cape Fear River, and a portion of Myrtle Grove Sound.

GENERAL INFORMATION:

- A. This proclamation is issued under the authority of N.C.G.S. 113-170.4; 113-170.5; 113-182; 113-221.1; 143B-289.52 and N.C. Marine Fisheries Commission Rules 15A NCAC 03H .0103 and 03K .0101.
- B. It is unlawful to violate the provisions of any proclamation issued by the N.C. Fisheries Director under his delegated authority pursuant to N.C. Marine Fisheries Commission Rule 15A NCAC 03H .0103.
- C. In accordance with N.C. General Statute 113-221.1(c) all persons who may be affected by proclamations issued by the Fisheries Director are under a duty to keep themselves informed of current proclamations.
- E. This proclamation returns the following areas to normal closure boundaries: A portion of Stump Sound, a portion of Newport River, a portion of North River, Ward Creek, a portion of Jarrett Bay, and Brett Bay.
- F. These reopenings are due to satisfactory bacteriological sampling results.
