PROCLAMATION

RE: SHELLFISH POLLUTED AREA

Kathy B. Rawls, Director, Division of Marine Fisheries, upon the recommendation of Betsey Tilson, M.D., M.P.H., State Health Director, Department of Health and Human Services, hereby announces that the following changes in shellfish harvesting areas will take effect at sunrise, Saturday January 22, 2022.

All those waters in Onslow and Carteret Counties will return to the status in existence immediately prior to the January 17, 2022, temporary closures **except the following which remains closed:**

ONSLOW / CARTERET COUNTIES

<u>All those waters</u> between the North Topsail Beach High-rise Bridge and the Surf City Bridge, to include Stump Sound.

<u>Queens Creek - All those waters in Queens Creek</u> upstream of a straight line across the mouth, beginning at a point 34° 39.8479'N - 77° 09.1171' W on the west shore; running northeasterly to a point 34° 40.2031'N - 77° 08.4408' W on the east shore near the State Park Boat Ramp.

White Oak River - All those waters in White Oak River upstream of a line beginning at a point 34° 41.9497' N - 77° 06.9846' W on the west shore; running easterly near the northern tip of Jones Island to a point 34° 41.9395' N -77° 05.6599' W on the east shore.

<u>Newport River - All those waters in Newport River</u> upstream of a line beginning at a point 34° 44.8271' N - 76° 42.1709' W on the south shore near Crab Point; running northeasterly to a point 34° 46.3210' N - 76° 41.2515' W on the west shore of Core Creek.

<u>Core Creek – All those waters in Core Creek</u> upstream of a line beginning at a point 34° 46.3210' N - 76° 41.2515' W on the west shore, running easterly near IWW Marker "25" to a point 34° 46.2251' N - 76° 40.5919' W on the east shore near the mouth of Ware Creek.

<u>North River - All those waters</u> upstream of a straight line beginning at a point 34° 44.4581′N - 76° 37.3826′ W on the shore south of Cow Pen Creek; running easterly near the old Fl. "Danger" Beacon to a point 34° 44.4929′ N - 76° 35.3320′ W on the northwest shore of Goose Bay, to include all of Ward Creek.

The following also remains closed:

BRUNSWICK / PENDER COUNTIES

<u>All those waters</u> bordered on the east by a line beginning at a point 33° 54.2904′ N - 78° 23.6416′ W on the mainland near the Bricklanding Road Public Boat Ramp and IWW Beacon "84"; running southerly to a point 33° 54.1932′ N - 78° 23.6426′ W on Ocean Isle Beach near Ferry Landing Park; and bordered on the west by the South Carolina State Line, to include Tubbs Inlet.

<u>Shallotte River - All those waters in Shallotte River</u> upstream of a line beginning at a point 33° 54.8302′ N - 78° 22.3626′ W near Bowen Point; running southeasterly to a point 33° 54.6139′ N - 78° 21.7667′ W on Long Point.

<u>Holden Beach - All those waters</u> bordered on the east by IWW Beacon "48A" (33° 55.2179′ N - 78° 14.5628′ W); and bordered on the west by a line beginning at a point 33° 54.6855′ N - 78° 21.3550′ W on the mainland; running southerly through IWW Marker "71" to a point 33° 54.4311′ N - 78° 21.2898′ W on Holden Beach near the end of Sea View Drive.

<u>Lockwoods Folly River - All those waters in Lockwoods Folly River</u> north of a line beginning at a point 33° 55.5678′ N - 78° 13.8043′ W on the south shore of Spring Creek near the mouth; running easterly to a point 33° 55.4621′N - 78° 13.1714′ W near the northern tip of Sheep Island; thence running southeasterly to a point 33° 55.2284′N - 78° 12.7791′ W near the northwest point of Horse Island, to include a portion of the Intracoastal Waterway north of Horse and Sheep Islands.

<u>All those waters</u> between the North Topsail Beach High-rise Bridge and the Surf City Bridge, to include Stump Sound.

GENERAL INFORMATION:

- A. This proclamation is issued under the authority of N.C.G.S. 113-170.4; 113-170.5; 113-182; 113-221.1; 143B-289.52 and N.C. Marine Fisheries Commission Rules 15A NCAC 03H .0103 and 03K .0101.
- B. It is unlawful to violate the provisions of any proclamation issued by the N.C. Fisheries Director under his delegated authority pursuant to N.C. Marine Fisheries Commission Rule 15A NCAC 03H .0103.
- C. In accordance with N.C. General Statute 113-221.1(c) all persons who may be affected by proclamations issued by the Fisheries Director are under a duty to keep themselves informed of current proclamations.
- D. This proclamation returns the following areas to normal closure boundaries: Salliers Bay, Freeman Creek, Bear Creek, a portion of White Oak River, Wade Creek, Jarrett Bay, Brett Bay, and Nelson Bay
- E. These reopenings are due to satisfactory bacteriological sampling results.
