### **PROCLAMATION**

#### **RE: SHELLFISH POLLUTED AREA**

Kathy B. Rawls, Director, Division of Marine Fisheries, upon the recommendation of Betsey Tilson, M.D., M.P.H., State Health Director, Department of Health and Human Services, hereby announces that the following changes in shellfish harvesting areas will take effect at sunrise, Wednesday, August 23, 2023.

All those waters in Carteret County will return to the status in existence immediately prior to the August 17, 2023 temporary closures, except the following which remain closed:

## **CARTERET COUNTY**

<u>Newport River - All those waters in Newport River</u> upstream of a line beginning at a point 34° 45.6960' N - 76° 43.5180' W on the south shore near Penn Point; running northeasterly to a point 34° 46.5733' N - 76° 42.6350' W on the north shore near the Hardesty Farms subdivision (near the Newport River DMF Shrimp Line).

<u>Core Creek – All those waters in Core Creek</u> upstream of a line beginning at a point 34° 46.3210' N - 76° 41.2515' W on the west shore, running easterly near IWW Marker "25" to a point 34° 46.2251' N - 76° 40.5919' W on the east shore near the mouth of Ware Creek.

North River - All those waters in North River upstream of a straight line beginning at a point 34° 42.1302′ N - 76° 36.0815′ W at the permanent closure line near Beacon "5"; running northeasterly to a point 34° 43.2724′ N - 76° 34.5238′ W on the mainland at the Harker's Island Bridge at The Straits.

### The following also remains closed:

# **BRUNSWICK COUNTY**

<u>All those waters</u> between the permanent closure line near IWW Marker "89" in Ocean Isle, and the South Carolina State Line, to include the Tubbs Inlet area.

<u>Lockwoods Folly River - All those waters</u> north of a line beginning at a point 33° 55.5678′ N - 78° 13.8043′ W on the south shore of Spring Creek near the mouth; running easterly to a point 33° 55.4621′N - 78° 13.1714′ W near the northern tip of Sheep Island; thence running southeasterly to a point 33° 55.2284′N - 78° 12.7791′ W near the northwest point of Horse Island, to include a portion of the Intracoastal Waterway north of Horse and Sheep Islands.

# **GENERAL INFORMATION:**

- A. This proclamation is issued under the authority of N.C.G.S. 113-170.4; 113-170.5; 113-182; 113-221.1; 143B-289.52 and N.C. Marine Fisheries Commission Rules 15A NCAC 03H .0103 and 03K .0101.
- B. It is unlawful to violate the provisions of any proclamation issued by the N.C. Fisheries Director under their delegated authority pursuant to N.C. Marine Fisheries Commission Rule 15A NCAC 03H .0103.

- C. In accordance with N.C. General Statute 113-221.1(c) all persons who may be affected by proclamations issued by the Fisheries Director are under a duty to keep themselves informed of current proclamations.
- D. This proclamation returns the following areas to normal closure boundaries: Whitehurst Creek, Sleepy Creek, Jarrett Bay, Oyster Creek, Brett Bay, Nelson Bay, Thorofare Bay, Barry Bay, Rumley Bay, Lewis Creek, and Cedar Island Bay.
- E. These openings are due to satisfactory bacteriological sampling results.
