PROCLAMATION

RE: SHELLFISH POLLUTED AREA

Kathy B. Rawls, Director, Division of Marine Fisheries, upon the recommendation of Kelly Kimple, M.D., M.P.H., Interim State Health Director, Department of Health and Human Services, hereby announces that the following changes in shellfish harvesting areas will take effect at sunrise, Saturday, March 22, 2025.

All those waters Brunswick, Onslow, and Carteret Counties will return to the status in existence immediately prior to the March 6, March 11, and March 17, 2025, temporary closures **except the following which remain closed:**

ONSLOW / CARTERET COUNTIES

<u>All those waters</u> bordered on the north by a line beginning at a point 34° 31.1227′ N - 77° 22.3142′ W on the mainland, running southerly near Beacon "15" to a point 34° 31.0527′ N - 77° 22.2654′ W on North Topsail Beach, near Galleon Bay; and bordered on the south by a line beginning at a point 34° 28.2180′ N - 77° 30.5521′ W on the mainland near Morris Landing, running southeasterly near Beacon "49" to a point on Topsail Island at 34° 27.273′ N -77° 29.937′ W, to include a portion of Stump Sound and Alligator Bay.

<u>Newport River - All those waters in Newport River</u> upstream of a line beginning at a point 34° 45.6960' N - 76° 43.5180' W on the south shore near Penn Point; running northeasterly to a point 34° 46.5733' N - 76° 42.6350' W on the north shore near the Hardesty Farms subdivision (near the Newport River DMF Shrimp Line).

<u>North River - All those waters</u> upstream of a straight line beginning at a point 34° 44.4581′N - 76° 37.3826′ W on the shore south of Cow Pen Creek; running easterly near the old Fl. "Danger" Beacon to a point 34° 44.4929′ N - 76° 35.3320′ W on the northwest shore of Goose Bay, to include all of Ward Creek.

GENERAL INFORMATION:

- A. This proclamation is issued under the authority of N.C.G.S. 113-170.4; 113-170.5; 113-182; 113-221.1; 143B-289.52 and N.C. Marine Fisheries Commission Rules 15A NCAC 03H .0103 and 03K .0101.
- B. It is unlawful to violate the provisions of any proclamation issued by the N.C. Fisheries Director under his delegated authority pursuant to N.C. Marine Fisheries Commission Rule 15A NCAC 03H .0103.
- C. In accordance with N.C. General Statute 113-221.1(c) all persons who may be affected by proclamations issued by the Fisheries Director are under a duty to keep themselves informed of current proclamations.
- D. This proclamation returns the following areas to normal closure boundaries: Tubbs Inlet, Ocean Isle Beach, Lockwoods Folly River, White Oak River, a portion of Newport River, Core Creek, a portion of North River, Sleepy Creek, Jarrett Bay, Oyster Creek, and Nelson Bay.
- E. These reopenings are due to satisfactory bacteriological sampling results.
