PROCLAMATION

RE: SHELLFISH POLLUTED AREA

Kathy B. Rawls, Director, Division of Marine Fisheries, upon the recommendation of Betsey Tilson, M.D., M.P.H., State Health Director, Department of Health and Human Services, hereby announces that the following change in a shellfish harvesting area will take effect at sunrise, Saturday, August 3, 2024.

All those waters in Carteret County will return to the status in existence immediately prior to the July 26 and July 27, 2024, temporary closures **except the following which remain closed:**

CARTERET COUNTY

<u>Newport River - All those waters in Newport River</u> upstream of a straight line beginning at a point 34° 45.6646' N – 76° 44.0603' W on the south shore near Lawton Point, running northerly to a point 34° 46.5724' N -76° 44.3786' W on the north shore just upstream of Hammock Rock.

<u>North River – All those waters in North River</u> upstream of a line beginning at a point on the west shore at 34° 46.0460' N - 76° 37.0517' W, running easterly to a point on the east shore at 34° 46.2731' N - 76° 35.4724' W (near the DMF Shrimp Line).

<u>Ward Creek - All those waters</u> in Ward Creek upstream of a line beginning at a point on the north shore at 34° 46.2731' N - 76° 35.4724' W, running southerly to a point on the south shore at 34° 45.4556' N - 76° 35.1587' W (near the Ward Creek DMF Shrimp Line).

The following also remains closed:

BRUNSWICK / NEW HANOVER COUNTY

<u>All those waters</u> between the permanent closure line near IWW Marker "89" in Ocean Isle, and the South Carolina State Line, to include the Tubbs Inlet area.

<u>All those waters</u> between IWW Beacon "1" near Southport and the permanent closure line near the Holden Beach Bridge and IWW Beacon "51A", to include Lockwoods Folly River and the Lockwoods Folly Inlet area.

<u>All those waters in Myrtle Grove Sound</u> bordered on the north by a line beginning at a point 34° 04.8476'N - 77° 53.0990' W on the mainland; running easterly near IWW Marker "155" to the southern tip of Masonboro Island at 34° 04.8251'N - 77° 52.9092' W; and bordered on the south by Snows Cut.

GENERAL INFORMATION:

- A. This proclamation is issued under the authority of N.C.G.S. 113-170.4; 113-170.5; 113-182; 113-221.1; 143B-289.52 and N.C. Marine Fisheries Commission Rules 15A NCAC 03H .0103 and 03K .0101.
- B. It is unlawful to violate the provisions of any proclamation issued by the N.C. Fisheries Director under his delegated authority pursuant to N.C. Marine Fisheries Commission Rule 15A NCAC 03H .0103.

- C. In accordance with N.C. General Statute 113-221.1(c) all persons who may be affected by proclamations issued by the Fisheries Director are under a duty to keep themselves informed of current proclamations.
- D. This proclamation returns the following area to normal closure boundaries: Bogue Sound.
- E. This reopening is due to satisfactory bacteriological sampling results.
