

# N.C. Division of Environmental Assistance and Customer Service Recycling in North Carolina



The Recycling and Materials Management Section (RMMS) helps expand and improve recycling infrastructure and programs in North Carolina. Waste reduction and recycling provide tremendous benefits to North Carolina's economy and environment by creating jobs and private investment, providing critical material supply to manufacturers, reducing dependence on landfills and saving natural resources.

### **Technical Assistance**

Local Governments: Municipal and county governments provide essential recycling services to residents statewide. RMMS supports local programs with training, expert advice and grants to expand services, increase material recovery and improve efficiency.



Recycling Businesses: More than 600 recycling companies in North Carolina help move recovered commodities from collection through processing and on to manufacturing new products. RMMS provides technical, business, and financial assistance to recycling companies, helping to grow jobs and private investment in NC.

**Waste Generators:** Commercial, institutional and industrial generators are striving to reduce waste to operate more sustainably and meet zero-waste-to-landfill goals. RMMS assists generators in implementing waste reduction efforts and finding recycling services and markets.

**State Agencies:** State departments, public universities and community colleges are significant waste generators. RMMS assists these agencies in optimizing their recycling efforts.

### **Grant Assistance**

# **Recycling Economic Development**

RMMS collaborates with the Economic Development Partnership of North Carolina, the Department of Commerce and local economic developers to recruit new recycling businesses to the state and help existing companies succeed and expand. This work improves local economies and creates high-quality jobs while improving the state's environmental and carbon footprint.

## **Special Focus on Food Waste**

RMMS facilitates collaboration and provides educational resources through the Use the Food NC campaign which promotes ways to eat, donate, compost or anaerobically digest food before landfilling. Grant funding and technical assistance from RMMS continue to build the state's infrastructure for donation and composting to make diversion opportunities more widely available.
