- Provide Technical Assistance and training services







RTI/NCCU Partnership


- RTI & NCCU established bilateral research partnership in 2020

- Established network for community engagement is critical for outreach



General Permits Renewal Animal Feeding Operations

Background – General Permits

- 3 State General Permits
 - AWG100000 Swine
 - AWG200000 Cattle/Dairy
 - AWG300000 Poultry with Liquid Waste Management System
 - Last Issued Oct. 1, 2019
- 3 State Farm Digester General Permits
 - AWG400000 Swine
 - AWG500000 Cattle/Dairy
 - AWG600000 Poultry with Liquid Waste Management System
 - First Issued July 1, 2022
- All expire Sept. 30, 2024
- New General Permits shall be effective Oct. 1, 2024 Sept. 30, 2029



General Permits Development Process

General Permits development will have significant public input

Stakeholder Process

- Technical Workgroup Sessions April 24 & May 3, 2023
- Public Input Session, Sampson Co. Expo Center May 9, 2023
- Accepted oral and written comments due by June 5, 2023

Post Draft General Permits online for public review — Aug. 3, 2023

Public Comment Period — Aug. 4-Nov. 3, 2023

- Four public meetings 3 in person; 1 online
- Accept oral, written, and electronic comments

General Permit Finalized by Jan. 2024

Additional outreach

- One-pager for community members + translation
- Interpretation, Spanish-language materials at hearings
- Dual-language voicemail line with instructions for comments
- Email/calls/mailing of materials to identified sensitive receptors (selected based on an AFO odor proximity analysis)
- Distribution of information through English and Spanish-language radio and print/online publications
- Engagement with 5 state or federally recognized tribes as recommended by the draft EJ report
- Consult known community leaders for additional outreach options



Timeline

- Comments received from Aug. 4-Nov. 3, 2023
- Permits to be finalized in January 2024
- Applications for the new permit mailed beginning in Feb. 2024
- Completed permit applications received by April 1, 2024 (180 days prior to expiration of current permits)
- Permits in effect Oct. 1, 2024
