The Division of Water Infrastructure (Division) has completed its review of the engineering report and environmental document for the subject project. Based upon the review, the Division has determined that the above-referenced project is eligible for funding as follows:

Eligible:

Replacement by parallel installation of approximately 9,200 LF of 8-inch, 4,800 LF of 10-inch and 600 LF of 16-inch gravity sewer pipe and 51 manholes; and rehabilitation of three (3) manholes.

Non-Eligible:

Paving of roadways in excess of the excavated area; spare parts, service contracts, and maintenance contracts; and extended warranties.

Based upon a detailed review of the future bid documents, the Division may determine that portions of the project are not eligible for funding and the total funding amount may be reduced.

Please note that funding is contingent on meeting the schedule provided in your *Letter of Intent to Fund*, or your approved Funding Deadline Extension approval letter (if applicable), as tabulated below:

All costs incurred prior to March 3, 2021, are not eligible for ARPA funds, and all ARPA funds must be expended prior to December 31, 2026. The Division will make no disbursement of ARPA funds after December 31, 2026.

Project Description:
