Thank you for your letter of April 11, 2017, concerning the above project.

There are no known archaeological sites within the proposed project areas. Given the topographic characteristics and land use histories of the proposed project areas, it is unlikely that any archaeological resources that may be eligible for listing in the National Register of Historic Places will be affected by the project. We therefore recommend that no archaeological investigations be conducted in connection with this project.

This letter is to inform you that a list of all federally-protected endangered and threatened species with known occurrences in North Carolina is now available on the U.S. Fish and Wildlife Service's (Service) web page at http://www.fws.gov/raleigh. Therefore, if you have projects that occur within the Raleigh Field Office's area of responsibility (see attached county list), you no longer need to contact the Raleigh Field Office for a list of federally-protected species.

Our web page contains a complete and frequently updated list of all endangered and threatened species protected by the provisions of the Endangered Species Act of 1973, as amended (16 U.S.C. 1531 et seq.)(Act), and a list of federal species of concern that are known to occur in each county in North Carolina.

Scction 7 of the Act requires that all federal agencies (or their designated non-federal representative), in consultation with the Service, insure that any action federally authorized, funded, or carried out by such agencies is not likely to jeopardize the continued existence of any federally-listed endangered or threatened species. A biological assessment or evaluation may be prepared to fulfill that requirement and in determining whether additional consultation with the Service is necessary. In addition to the federally-protected species list, information on the species' life histories and habitats and information on completing a biological assessment or evaluation and can be found on our web page at http://www.fws.gov/raleigh. Please check the web site often for updated information or changes.

The term "federal species of concern" refers to those species which the Service believes might be in need of concentrated conservation actions. Federal species of concern receive no legal protection and their designation does not necessarily imply that the species will eventually be proposed for listing as a federally endangered or threatened species. However, we recommend that all practicable measures be taken to avoid or minimize adverse impacts to federal species of concern.

If your project contains suitable habitat for any of the federally-listed species known to be present within the county where your project occurs, the proposed action has the potential to adversely affect those species. As such, we recommend that surveys be conducted to determine the species' presence or absence within the project area. The use of North Carolina Natural Heritage program data should not be substituted for actual field surveys.

If you determine that the proposed action may affect (i.e., likely to adversely affect or not likely to adversely affect) a federally-protected species, you should notify this office with your determination, the results of your surveys, survey methodologies, and an analysis of the effects of the action on listed species, including consideration of direct, indirect, and cumulative effects, before conducting any activities that might affect the species. If you determine that the proposed action will have no effect (i.e., no beneficial or adverse, direct or indirect effect) on federally listed species, then you are not required to contact our office for concurrence (unless an Environmental Impact Statement is prepared). However, you should maintain a complete record of the assessment, including steps leading to your determination of effect, the qualified personnel conducting the assessment, habitat conditions, site photographs, and any other related articles.

With regard to the above-referenced project, we offer the following remarks. Our comments are submitted pursuant to, and in accordance with, provisions of the Endangered Species Act.

Based on the information provided and other information available, it appears that the proposed action is not likely to adversely affect any federally-listed endangered or threatened species, their formally designated critical habitat, or species currently proposed for listing under the Act at these sites. We believe that the requirements of section 7(a)(2) of the Act have been satisfied for your project. Please remember that obligations under section 7 consultation must be reconsidered if: (1) new information reveals impacts of this identified action that may affect listed species or critical habitat in a manner not previously considered; (2) this action is subsequently modified in a manner that was not considered in this review; or, (3) a new species is listed or critical habitat determined that may be affected by the identified action.

However, the Service is concerned about the potential impacts the proposed action might have on aquatic species. Aquatic resources are highly susceptible to sedimentation. Therefore, we recommend that all practicable measures be taken to avoid adverse impacts to aquatic species, including implementing directional boring methods and stringent sediment and crosion control measures. An erosion and sedimentation control plan should be submitted to and approved by the North Carolina Division of Land Resources, Land Quality Section prior to construction. Erosion and sedimentation controls should be installed and maintained between the construction site and any nearby down-gradient surface waters. In addition, we recommend maintaining natural, vegetated buffers on all streams and creeks adjacent to the project site.

The North Carolina Wildlife Resources Commission has developed a Guidance Memorandum (a copy can be found on our website at (http://www.fws.gov/raleigh) to address and mitigate secondary and cumulative impacts to aquatic and terrestrial wildlife resources and water quality. We recommend that you consider this document in the development of your projects and in completing an initiation package for consultation (if necessary).

We hope you find our web page useful and informative and that following the process described above will reduce the time required, and eliminate the need, for general correspondence for species' lists. Mr. Humphrey,

I've reviewed the "Categorical Exclusion" (CE) request for the demolition and re-build of the "elevated storage tank" in Reelsboro, NC (35.132031, -76.926175) and for the construction of the "check valve vault" in Alliance, NC (35.145582, -76810502). Based on a desk top review it doesn't appear as though any jurisdictional wetlands or Waters of the US will be impacted or filled by either of these two projects, so no permit will be required from the USACE.

While Pamlico County, NC is within the range of the Northern Long Eared Bat (Myotis septentrionalis) no known colonies exist in Pamlico County. As an added measure perhaps you can have your workers double check the underside of the tank prior to its demolition to see if there might be any bats roosting underneath it. Though they seem to prefer roosting in older, mature trees. They have been seen roosting under bridges and old barn eaves in North Western, NC.

I hope this e-mail will suffice as your "written" Categorical Exclusion, if not I can put something together for you on official USACE letterhead.

Reelsboro Elevated Storage Tank Replacement Environmental Assessment – USACE Permits



As part of the funding application and permitting process, Pamlico County is submitting a Request for Categorical Exclusion from Substantive Environmental Review (CE) for the subject project.

This memorandum is intended to serve as documentation that no USACE permits are required for this project. The project will occur entirely on existing partially developed sites, and no impacts to wetlands or surface waters are anticipated. Some clearing of a wooded area on the existing tank site will be required. However, I have determined that no US Army Corps of Engineers permit is required.
