Question 31. In 2018-2019 the municipality no longer offers electronics recycling. Any electronics picked up with trash are taken to County transfer station which charges the municipality a per piece disposal fee which is passed on the the municipal garbage customer by the municipality. Customers are no longer putting out electronics for pickup, therefore, our municipality does not have a recycling program for electronics for the 2018-2019 report year. (historical note DH)

Question # 41 - Clarification for Question # 41: The Town of Tryon provides recycling receptacles at its parks and plazas within the city limits and encourages festival/event planners using those areas to use the on-site recycling bins so that recycled materials can be recovered from these events. These collections are collected with curbside collections weekly and are included in those totals reported for each type of material recycled and cannot be estimated as separate collections (Email Correspondence with staff a Town of Tryon on Oct 17, 2019 -DH note)

Question 43. There were no white goods recycled by our municipality in the 2018-2019 report year. (Town Note from staff)

Question 44: Details on the MRFs and Recycled Materials handlers used by the Town: Tryon has dual stream recycling and does not use single stream. Various materials are delivered to different companies. Some recyclables go to the Polk County Transfer Station and the Rutherford County Landfill and they would then be handled by whomever those public entities send thier recyclables to. It is for this reason the Question # 44 was answered as Republic's Conover Facility. Also, in May & June 2019, Tryon began contracting with Pratt Recycling of Georgia to take our mixed paper that had been going to Rutherford County Landfill for recycling to reduce recycling cost for mixed paper. All of these entities charge Tryon for providing this recycling service. To try to recover some of the costs of our small town recycling program, Tryon sells cardboard to American Recycling of WNC in Candler and Tryon sells metal cans to CRC Scrap Metal of Duncan SC. The city did not give a breakdown of how much materials go to which facility (Email Correspondence with staff a Town of Tryon on Oct 17
