

Funding Actions Taken at the July 13-14, 2022 Meeting of the State Water Infrastructure Authority on the Applications Submitted in May 2022 to the Division of Water Infrastructure

On May 2, 2022, the Division of Water Infrastructure (Division) received applications for funding for drinking water projects, wastewater projects, pre-construction planning grants, merger / regionalization feasibility project grants (MRF), and asset inventory and assessment grants (AIA). The sources of funding for the Spring 2022 applications are:

- Viable Utility Reserve (VUR)
- Drinking Water Reserve (State Reserve)
- Wastewater Reserve (State Reserve)
- Drinking Water State Revolving Fund (DWSRF)
- Clean Water State Revolving Fund (CWSRF)

Tables 1 and 2 show the amount of funding requested in applications that were complete and eligible for funding. On July 14, 2022, the State Water Infrastructure Authority (Authority) determined the eligibility of applications selected to receive funding from the available funding sources listed above. Note that American Rescue Plan Act (ARPA) State Fiscal Recovery Funds appropriated in S.L. 2021-180 and S.L. 2022-74 were awarded by the Authority via the State Reserve and VUR.

Table 3 shows a summary of the number of applications that were approved for full or partial funding at the Authority’s July 14, 2022 meeting, and Table 4 shows the amount of funding approved by program. A total amount of \$789,421,348 was approved for funding in grants and loans for 385 applications, including \$216,905,674 from the VUR that is conditional based upon approval by the Local Government Commission (LGC). The funded applications are in 86 counties across the state, shown in Figure 1.

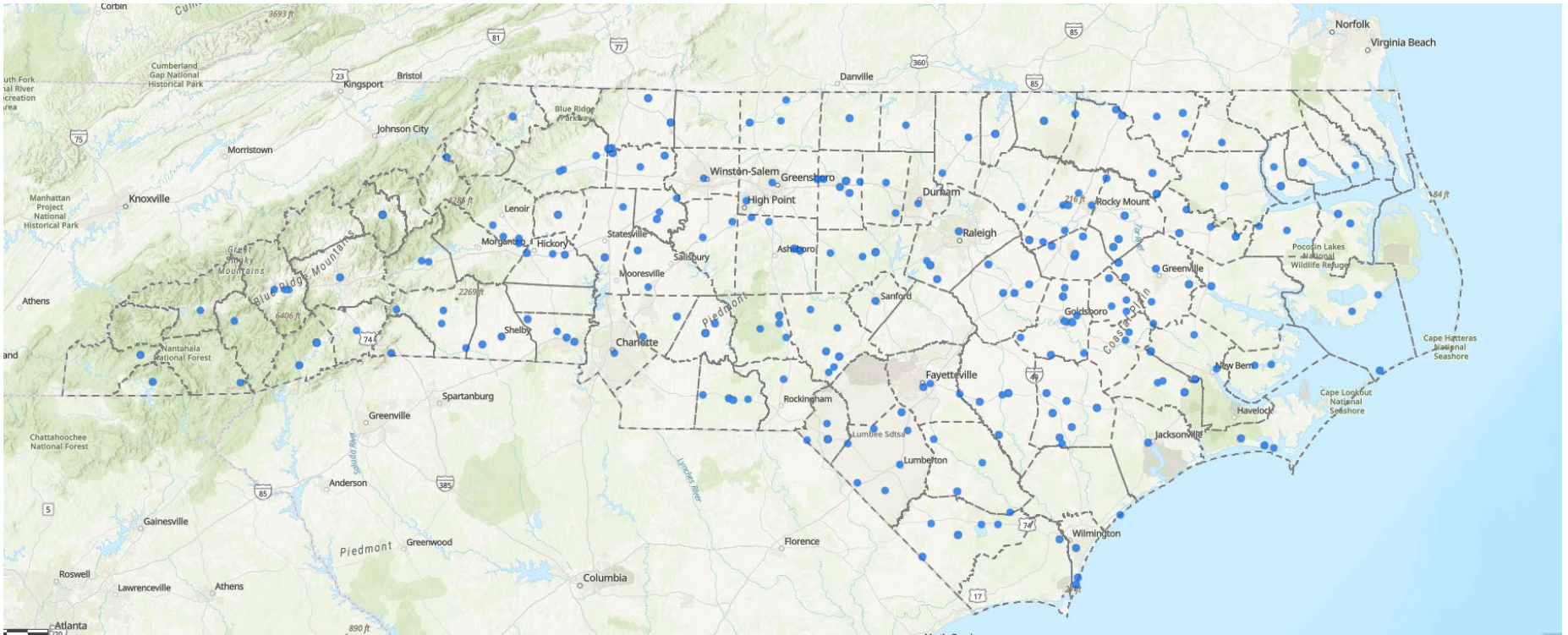
