

Applications selected for funding by the State Water Infrastructure Authority on September 17, 2025

On September 17, 2025, North Carolina's State Water Infrastructure Authority (SWIA) approved funding assistance (loans and/or grants) for the following applications. Applicants will be notified of their funding awards by the NC Department of Environmental Quality's Division of Water Infrastructure with a Letter of Intent to Fund.

Construction project types include Infrastructure Investment and Jobs Act (IIJA) Lead Service Line Replacements, and Supplemental Appropriation for Hurricanes Helene and Milton and Hawai'i Wildfires (SRF Helene) Drinking Water State Revolving Fund and Clean Water State Revolving Fund.

Planning project types include IIJA Drinking Water Emerging Contaminants Evaluation/Assessment Studies and IIJA Lead Service Line Inventories.
