

Applications selected for funding by the State Water Infrastructure Authority on February 18, 2026

On February 18, 2026, North Carolina's State Water Infrastructure Authority (SWIA) approved funding assistance (loans and/or grants) for the following applications. Applicants will be notified of their funding awards by the NC Department of Environmental Quality's Division of Water Infrastructure with a Letter of Intent to Fund.

Construction project types include Drinking Water, Wastewater, Infrastructure Investment and Jobs Act (IIJA) Drinking Water Emerging Contaminants, IIJA Lead Service Line Replacements, State Revolving Fund Supplemental Appropriation for Hurricanes Helene, Milton, and Hawai'i Wildfires (SA-HMW, known in North Carolina as SRF Helene).

Planning project types include Asset Inventory and Assessments, Merger/Regionalization Feasibility, IIJA Drinking Water Emerging Contaminants Evaluation/Assessment Studies, and IIJA Lead Service Line Inventories.
