Draft Updated Project Priority List for BIL CWSRF-EC Funds – as of Feb 2025

Last updated: February 28, 2025

The Intended Use Plan Project Priority List may be supplemented or replaced based on applications received as a part of future funding cycles.

In November 2024, North Carolina Department of Environmental Quality's (NC DEQ) Division of Water Infrastructure (Division) received a conditional award from the U.S. Environmental Protection Agency (US EPA) for the FY2024 Bipartisan Infrastructure Law (BIL) Clean Water State Revolving Fund – Emerging Contaminants (CWSRF-EC) capitalization grant. The US EPA conditionally approved the Division's Intended Use Plan and required the Division to submit a revised Intended Use Plan with an updated Project Priority List prior to NC DEQ receiving the full \$3.83 million capitalization grant from US EPA.

\$5,804,960 was awarded to applicants in the February 2024 meeting of the State Water Infrastructure Authority (SWIA) from CWSRF-EC funds from the FY2022, FY2023, and partially from the FY2024 capitalization grants. These funding awards were previously presented in a public comment period in May – June 2024 and included in the final Intended Use Plans.

Since then, the Division received new applications and reconsidered previously partially funded applications for additional CWSRF-EC funding. The State Water Infrastructure Authority awarded \$2,419,000 CWSRF-EC funds in February 2025, pending receipt of those funds from US EPA. Those awards, listed below, comprise the latest update to the Project Priority List which will be submitted to US EPA for approval to receive additional funds from the conditionally-approved FY2024 capitalization grant.

Prior to this submittal, the latest update to the Project Priority List, shown below, is available for public comment. The Intended Use Plan itself underwent a public comment period between March 1 and April 1, 2024, and was finalized in September 2024. The Project Priority List is proposed to be expanded to include the February 2025 projects shown below. Funding awards were made in accordance with the Intended Use Plan. All additional subsidy is provided as principal forgiveness. The Project Priority List items the output/outcomes of the policies and procedures outlined in the Intended Use Plans for the FY2022, FY2023 and FY2024 funds.
