- 3. Fall 2025 application is due by 5:00pm on September 30. SWIA will award on February 18, 2026.
- 4. SRP grants are limited to \$3M per eligible applicant every three years. However, applications will also be considered for other funding programs (e.g. SRF loans).
- 5. Can apply for both: SRF Helene (Rolling Application) and Fall 2025 Applications. Apply separately.


SRF Helene Funding



NC's "SRF Helene" Funds

"SRF SA-HMW" or "SRF Helene"

North Carolina's allotments from the Supplemental Appropriations (including set-asides)



Administered under current SRF program, but funds are dedicated to eligible projects that address Helene impacts.

New program. Has some CWSRF requirements but will be partly unique. Dedicated to eligible projects in Helene-impacted areas.

Purpose of SRF Helene

DWSRF/CWSRF:

"... reduce flood or fire damage risk and vulnerability or to enhance resiliency to rapid hydrologic change or natural disaster


CWSRF Decentralized:

"... improve the resilience of decentralized wastewater treatment systems to flooding, to assess the potential to connect homes ... to centralized systems, and to fund such connections."

In short:
"Improve flood resilience"

Preliminary Requests from Pre-Applications

To understand the potential funding needs before applications were available, we asked potential applicants to identify preliminary project needs.



SRF Helene – Eligible Applicants

DWSRF/CWSRF Helene Eligible Applicants:

- Local Government Units (including Counties and Districts)
- Non-profit water/wastewater utilities
- Investor-owned drinking water utilities (DWSRF only)

Must have been impacted by Hurricane Helene.

CWSRF Helene Decentralized Eligible Applicants:

- Local Government Units (including Counties and Districts)
- Non-profit wastewater utilities
- CDFIs and nonprofit organizations that finance homeowners for decentralized wastewater treatment system repairs

Must be in a Helene-affected area.

Applicants may contract with other organizations.

Examples of Eligible Projects for CWSRF/DWSRF Helene

- Projects that prevent interruption of operation during a flood event
- Projects that prevent floodwaters from entering treatment works
- 3. Projects that maintain integrity of treatment in the event of a flood or natural disaster
- Projects that preserve and protect treatment works equipment in the event of a flood
- Projects that provide public water/sewer service to affected homes served by private wells or septic systems
- 6. Physical hardening or water proofing of impacted water/sewer infrastructure including buildings

Examples of Eligible Projects for CWSRF Helene Decentralized

- 1. Projects that protect DWTS from rising waters
- 2. Projects that protect DWTS from power risks associated with flooding (backup power/power shutoffs)
- 3. Projects that reduce the risk of DWTS failure associated with flooding (water tightening or elevating)
- 4. Projects that increase DWTS capacity to handle flood risk (additional drain lines, larger tanks)
- Consolidation of DWTS to reduce flood risk
- 6. Planning projects to assess potential to connect to centralized systems
- 7. Projects that make connections to centralized systems and decommissioning DWTS

SRF Helene Loan Terms

DWSRF Helene:

for drinking water systems

CWSRF Helene:

for wastewater systems (POTWs) CWSRF
Decentralized
Helene:

for decentralized/ septic systems


0% interest loans, typically 20 years.
All loans include a principal forgiveness portion, based on affordability/economic constraints and system size (either 30%, 50%, or 75%; and sometimes the first \$5M is at 100% principal forgiveness)

100% Principal Forgiveness (no loan repayments)

SRF Helene Loan Terms

CWSRF Helene Decentralized: 100% principal forgiveness loan.

<u>DWSRF/CWSRF Helene:</u> Repayable loans have 0% interest and typically 20-year terms. LGC must approve loan portion. <u>All</u> loans will receive a portion of principal forgiveness (PF) as follows:



SRF Helene Rolling Applications

Applications (now available) are taken on a rolling basis. Using the "Rolling Application".

Applications received by cutoff dates will be reviewed at the next SWIA meeting for awards:

- August 1, 2025 for September 17, 2025 awards (completed)
- November 3, 2025 for December 10, 2025 awards
- January 9, 2026 for February 18, 2026 awards
- March 2, 2026 for April 15-16, 2026 awards

Applications will be scored according to SWIA's Priority Rating Systems and awarded in priority order in each SWIA meeting.

SRF Helene Programmatic Specifics

- Potential initial funding caps through April 2026 (subject to change)
 - \$5M per applicant for WW projects
 - \$10M per applicant for DW projects
 - Initial caps for Decentralized projects will be determined based on applications
 - Capped awards may receive an increase after April 2026 based upon availability
- Applicant SRF caps
 - \$200M debt to the DWSRF
 - \$200M debt to the CWSRF

SRF Helene Programmatic Specifics (cntd.)

- DWSRF/CWSRF Helene Small Systems Reserve: 30% reserved for systems serving up to 10,000 people through April 2026
- CWSRF Helene Decentralized Reserve: ~50% reserved for decentralized WTS repair/replacements only (no sewer connections) through April 2026
- Loan fee 2% closing fee
 - Can be paid from the funding award
- Federal cross-cutters apply: ER/EID, Davis-Bacon wages, AIS, etc.
 - Build America, Buy America (BABA) does <u>not</u> apply
- Earlier disbursements (always on costs incurred)
 - ≤ 15% of project awards may be disbursed for planning/design costs incurred before construction contract execution
 - No repayable loan disbursed without LGC approval
- No duplication of funding from other sources (e.g., funded via FEMA, HMGP, USDA, EDA, etc.)

CWSRF Helene Decentralized – Programmatic Specifics

- All funds 100% principal forgiveness
- 2% closing fee
 - Can be paid from the funding award
- Up to 7% can be budgeted for grant administration costs (excluding Engineering and permitting costs)
- Residents may not be charged for funded work without first discussing with DWI (additional requirements)
- Projects proposing connecting to sewer lines must identify where the connections will take place
- Project proposing to remediate DWTSs must detail how the project team will ensure meeting 50% thresholds (for line items 1.A and 1.B)

CWSRF Helene Decentralized – Programmatic Specifics (cntd.)

- Funds must be expended in an expeditious and timely manner
- All awarded projects must meet milestones
- Costs associated with an executed funding offer must be incurred before requesting disbursements
- All funds spent within 5 years or by December 2031 (whichever comes first)
- Funds subject to all SRF conditions (except for BABA)

SRP Grant Funding



Fall 2025 State (SRP) Grant Funding

- Fall 2025 applications are considered for CDBG-I grants, SRF loans, State Reserve Program (SRP) grants and loans, and Viable Utility Reserve grants.
- SL 2025-26, Section 3.6, requires SWIA to prioritize state grants in this fiscal year for Helene repairs.
- Fall 2025 includes \$30 million in SRP grants. Eligible applications will be prioritized before using remaining SRP grants for other purposes (e.g., AIA or MRF funding).

SL 2025-26 Grant Funding Prioritization

Applications must meet <u>all</u> of the following:

✓ Local government or non-profit water/wastewater utility in one of these counties:

Ashe, Avery, Buncombe, Burke, Caldwell, Cleveland, Haywood, Henderson, Madison, McDowell, Mitchell, Polk, Rutherford, Transylvania, Watauga, Yancey.

- ✓ Project to repair, replace, or construct equipment, buildings, or natural features due to damage or effects from Hurricane Helene, including capacity building.
- ✓Only for the amount of unmet need above the amount paid by insurance and available federal aid.
- ✓ All NC GS 159G eligibilities for SRP grants ✓ \$3M/applicant cap per three consecutive years.

Fall 2025 Applications

- Due September 30, 2025, <u>at 5:00pm</u>.
- SWIA awards on February 18, 2026.
- One application form. Will be considered for all eligible funding (SRF, CDBG-I, SRP, VUR), based on priority points, eligibility, availability. Match with best available funding.
- Applicants are eligible to receive funding from multiple sources (e.g. SRP grant, SRF Helene, base SRF). Apply for SRF Helene as well (separate application – use Rolling Application).
- For previously-awarded projects, SWIA will only award any *additional* funding needed for the project (not swapping older awards with new awards).
