

## Applications selected for funding by the State Water Infrastructure Authority on December 10, 2025

On December 10, 2025, North Carolina's State Water Infrastructure Authority (SWIA) approved funding assistance (loans and/or grants) for the following applications. Applicants will be notified of their funding awards by the NC Department of Environmental Quality's Division of Water Infrastructure with a Letter of Intent to Fund.

Projects are funded from the Supplemental Appropriation for Hurricanes Helene and Milton and Hawai'i Wildfires ("SRF Helene") for the the Drinking Water State Revolving Fund and Clean Water State Revolving Fund, the Infrastructure Investment and Jobs Act (IIJA) funding for Lead Service Line Replacements, and the Clean Water State Revolving Fund for the Decentralized Wastewater Treatment System Pilot Program.

Funding Program Abbreviations: **DWSRF-HEL** = Drinking Water SRF Helene; **CWSRF-HEL** = Clean Water SRF Helene; **DWTS-HEL** = Clean Water SRF Helene funding for Decentralized Wastewater Treatment Systems; **IIJA DWSRF-LSLR** = IIJA DWSRF Lead Service Line Replacement; **CWSRF** = Clean Water State Revolving Fund.
