

NON-DISCHARGE PERMIT OWNERSHIP/NAME CHANGE INSTRUCTIONS FOR FORM: NDPONC 06-16 & SUPPORTING DOCUMENTATION

This form is for ownership changes or name changes of a non-discharge system permit. Please note that "Permittee" references the existing permit holder, and that "Applicant" references the entity applying for the ownership/name change.

A. Non-Discharge Permit Ownership/Name Change (FORM: NDPONC 06-16) Application (All Applications):

Submit an original completed and appropriately executed Non-Discharge Permit Ownership/Name Change (FORM: NDPONC 06-16) application.

The Existing Permittee's Certification shall be signed in accordance with <u>15A NCAC 02T .0106(b)</u>. Per <u>15A NCAC 02T</u> .0106(c), an alternate person may be designated as the signing official if a delegation letter is provided from a person who meets the criteria in <u>15A NCAC 02T .0106(b)</u>.

The Applicant's Certification shall be signed in accordance with <u>15A NCAC 02T .0106(b)</u>. Per <u>15A NCAC 02T .0106(c)</u>, an alternate person may be designated as the signing official if a delegation letter is provided from a person who meets the criteria in <u>15A NCAC 02T .0106(b)</u>.

B. **Existing Permit** (All Applications):

Submit a copy of the most recently issued permit.

- C. Property Ownership Documentation (All Applications):
 - Per <u>15A NCAC 02T .0504(f)</u>, <u>15A NCAC 02T .0604(e)</u>, <u>15A NCAC 02T .0704(f)</u>, <u>15A NCAC 02T .0804</u>, <u>15A NCAC 02T .1004(d)</u>, <u>15A NCAC 02T .1104(d)(7)</u>, <u>15A NCAC 02T .1104(e)(5)</u>, <u>15A NCAC 02U .0201(e)</u> or <u>15A NCAC 02U .0202(f)</u>,

the Applicant shall demonstrate they are the owner of all property containing the non-discharge system facilities: Legal documentation of ownership (i.e., <u>GIS</u>, deed or article of incorporation), or

Written notarized intent to purchase agreement signed by both parties with a plat or survey map, or

Written notarized lease agreement that specifically indicates the intended use of the property and has been signed by both parties, as well as a plat or survey map. Lease agreements shall adhere to the requirements of <u>15A NCAC 02L .0107</u>.

- D. Certificate of Public Convenience and Necessity (All Applications where the Applicant is a Privately-Owned Public Utility): Per <u>15A NCAC 02T .0115(a)(1)</u>, provide one copy of the Certificate of Public Convenience and Necessity from the <u>North</u> <u>Carolina Utilities Commission</u> demonstrating the Applicant is authorized to hold the utility franchise for the area to be served by the non-discharge system.
- E. **Operational Agreements** (All Applications where the Applicant is a Home/Property Owners' Association or Developer of lots to be sold):
 - Home/Property Owners' Associations
 - Per <u>15A NCAC 02T .0115(c)</u>, submit an original properly executed <u>Operational Agreement (FORM: HOA)</u>. Per <u>15A NCAC 02T .0115(c)</u>, submit an original proposed or approved Articles of Incorporation, Declarations and Bylaws.
 - Developers of lots to be sold Per <u>15A NCAC 02T .0115(b)</u>, submit an original of the properly executed <u>Operational Agreement (FORM: DEV)</u>.
- F. Operation and Maintenance Agreement (All Applications for Single-Family Wastewater Irrigation Systems): Per <u>15A NCAC 02T .0604(h)</u>, submit an original of a notarized <u>Operation and Maintenance Agreement (FORM: SFRWWIS</u> <u>0&M</u>) that has been signed and dated by all deeded property owners.
