### #230801 Approval of Animal Waste Biogas Digester Needs-to-Know Document

Dr. Rubin shared that they compiled data from other states and came up with about 6hrs worth of training which would include animal waste operator training for those who are operating animal waste digesters. They will start with training extension agents in counties where they are hosting some of these digesters and make changes to training material as needed.

### INFORMATION ITEMS

### 2308 – A Op Cert Staff – Information on AW Fee Changes

The General Assembly passed session law 2023-63 with the goal was to align animal waste fees with wastewater fees. As a result, animal waste operator exam fees were increased to \$85. The renewal fee was increased from \$10 to \$25. Animal waste operators will now pay a late fee of \$50 if they miss the January deadline for renewals.

2308 – B Carolyn Bynum – NCRWA Workforce Development Coordinator – NCRWA Apprenticeship program: Creating a pipeline to the Next Generation of Water Industry Operators.

There will be 50% of operators retiring in the next 5 to 7 years. The NCRWA has developed a registered apprenticeship program to help address this issue. They are registered with the Federal Department of Labor and Apprenticeship program in NC to help train these new operators. This program helps utilities find talent that is truly interested in participating and working as an operator in a utility. There will be 4,000 hrs. of on-the-job training and 288 hrs. of related technical instruction. Each person will go through a vetting process to qualify and be placed with the system.

# 2308 – C Trish Angoli – Environmental Engineer with the On-Site Water Protection Branch, Environmental Health Section, DHHS – New on-site wastewater rules and potential future issues.

Rule 15A NCAC 18E will replace the 1900 rules 15A NCAC 18A.

Changes have been made to 18E by session law 2023-77, but 18E is still on track to become effective on January 1, 2024. This new rule updates the list of systems that require an operator to better reflect the current systems that are in use within North Carolina. They removed some duplicates of systems, and added systems that weren't previously listed. A rule devoted to management responsibilities was also added. Rule 1711 is another new Rule, which deals with provisional and innovative approval renewal. These systems cover anything that's not specifically listed in a rule. Manufacturers need to submit a very simple renewal form for these systems. As there are more operators going to the private sector, they want to be able to make sure it is in place to ultimately protect the homeowner, public health, and the environment.
