

Funding Actions Taken at the April 14, 2021 Meeting of the State Water Infrastructure Authority on the Applications Submitted in November 2020 to the Division of Water Infrastructure for the Community Development Block Grant – Infrastructure Program

On November 23, 2020, the Division of Water Infrastructure received applications for funding for the Community Development Block Grant – Infrastructure (CDBG-I) projects. Table 1 shows the amount of funding considered in applications that were complete and eligible and the approximate amount of funding available. On April 14, 2021, the State Water Infrastructure Authority determined the eligibility of applications selected to receive funding from the CDBG-I program.

The Authority approved 17 projects for a total of \$27,371,097. \$1,539,304 will be from FY 2015 or FY 2016 deobligated funds while \$25,831,793 will be from FY 2020 funds.
